## Client Care Package Plan Client Disclosure Agreement Form

The IRS is projected to mail out over **170 million automated notices in 2026 to unsuspecting taxpayers** leveraging Artificial Intelligence in addition to relying on their own work force. Most of these notices will be downright incorrect, costing taxpayers millions of dollars to defend and prove their “innocence”. In 2026, your chances of receiving one of these notices questioning items on your return or informing you you’re being audited or that your tax identity was **stolen has increased significantly due to increased IRS funding, automation, all the new tax law changes, plus the increase in scams plaguing ordinary Americans.**

It can cost anywhere from \$275 to \$500 and up just to respond to an uncomplicated IRS/State computer generated notice that’s incorrect. Defending an actual audit or having your tax ID stolen can add real financial stress to your life. Audit representation fees alone can range from \$3,500-\$10,000 and up. To safeguard you from incurring any of these unforeseen expenses, we’ve created our Client Care Package. - ✓ We’ll represent and defend you in case of an IRS or State Income Tax Audit. We’ll waive our hourly audit fee for up to 10 hours of audit representation. Additional hours will be billed at our regular rate of \$325/hour. (Value = Regular fee: \$3,500 retainer + \$325/hour).

This protection becomes effective upon the filing of your 2025 Form 1040 and protects you for 3 years (4 years for state) from the date your 2025 return was filed.

## **“Worry-Free” Client Care Package**

Again this year, most of our clients, that meet certain qualifications, will automatically be enrolled into the Silver Level of our “Worry-Free” Client Care Service Plan (which also includes Audit Protection Defense) covering your 2025 federal and state income tax return for correspondence response, Audit Representation and Tax Identity Theft, and much more, for one low annual fee. The Client Care Package fee will be added as a separate line item on your Tax Preparation Invoice.

As you know, your return may be randomly selected for review by the taxing authorities, especially given all the recent and anticipated tax law changes as well as the \$80 billion the IRS recently received to ramp up their audit and enforcement efforts. Fees associated with responding to notices, audit representation, and Tax Identity Theft not due to our error are included in the Client Care Package’s nominal annual fee.

If you choose not to participate in the Client Care Package Service Plan and you receive a notice for any reason (other than due to our error), selected for an audit, or had your tax identity stolen, you will be billed for the services that would have been otherwise covered by the Client Care Package Service Plan at our hourly billing rate.
